The club was closed at the start of the pandemic and has now been leased to our private group for self operation. We are seeking community-based business support to enable our re-start in year 3!

Any monetary contributions will go towards clubhouse needs/improvements and providing a great experience for member families. The facility sat dormant for over 2 years due to COVID mandates, and there are some necessary services that must be done due to that period of closure. We accomplished some items last year, but more exist, and there will be continued upkeep to maintain the pristine condition of the property as time goes on.

I am happy to report that last year, we had 161 families as keyholders. The membership is open to any resident in the surrounding area. As in the past, we will welcome homeowners from Rudgate, Applegate Trails, Texas Heights, Applegate Pointe, Inverness, and all other neighboring communities. It was fantastic to see so many families making memories together at the pool in 2024. It's exciting to be able to offer that amenity to homeowners in the Texas Corners area once again!
